TOWN AND COUNTRY PLANNING (COUNTY OF EAST SUSSEX) _____DIRECTION, 1959

Under the provision of the Town and Country Planning General Development Order, 1950, (now superseded by the Town and Country Planning General Development Order, 1963), subject to certain conditions, the erection on agricultural land of more than one acre of any building requisite for the use of that land for the purpose of agriculture, which includes buildings for poultry production, constitutes 'permitted development', for which planning consent is not required.

This freedom from control is, however, modified by the Town and Country Planning (County of East Sussex) Direction 1959, which makes it necessary for planning permission to be obtained for the erection of any structure for the purposes of poultry production, including the breeding, hatching, sexing, rearing, killing, plucking or dressing of poultry, or the keeping of poultry for the production of eggs, where such structure:-

- (i) along or together with any structure or any part of which is within a distance of 100 feet therefrom, exceeds 12,000 cubic feet (as ascertained by external measurements) or
- (ii) exceeds 2,000 square feet in floor space (as ascertained by external measurement) and in the case of a building with a ridge roof, exceeds 7 feet in height at the ridge or 5 feet at the eaves, and in any other case exceeds 5'6" in height.

Town and Country Planning General Development Order, 1950

I am directed by the Minister of Housing and Local Government to refer again to your letter of 5th June enclosing for the Minister's approval an Article 4 Direction to control broiler houses within the five rural districts of the Administrative County.

The direction has received careful consideration. The Minister appreciates the extent of the problem within the county and is satisfied that control should be given in certain areas where the threat is most widespread and immediate. He is however, as you are aware, reluctant to approve the use of Article 4 more widely than is strictly necessary, and on the evidence presented considers that in certain other parts of the county it should be possible to continue for the present to deal with the problem by means of discussion or by individual directions in cases of urgency.

The Minister has therefore decided to approve the direction, with modifications to limit it to the rural district of Uckfield and to nine parishes in the Hailsham Rural District and seven parishes in the Battle Rural District. The parishes are:-

Laughton, East Hoathly, Waldron, Heathfield, Chiddingly, Horam, Warbleton, Ripe, Chalvington

Ticehurst, Burwash, Etchingham, Hurst Green, Dallington, Brightling, Salehurst.

The Minister has also considered representations from the rural district councils of Uckfield and Battle that the direction should be modified to make it more restrictive as regards the size of buildings and groups of buildings to be controlled, but has decided that he would not be justified in extending the scope of the direction in this way.

Formal approval will be issued as soon as possible.

Copies of this letter are being sent to the Clerks of the rural district councils of Uckfield and Battle.
