Mid Sussex District Council ("the Council") hereby gives notice in accordance with Section 70 of the Planning (Listed Buildings and Conservation Areas) Act 1990 as amended, that on the 1st November 2019, boundary changes to the East Grinstead Conservation Area in West Sussex were confirmed. This followed a public consultation on the draft East Grinstead Conservation Area Appraisal between Monday 17 June until Monday 29 July 2019.

- 2. Permitted Development rights are restricted within Conservation Areas;
- 3. Additional controls over demolition;
- 4. Additional publicity must be given to planning applications within Conservation Areas;

5. Notice must be given to the Council before work can be carried out to trees within Conservation Areas
