<b>Describe the premises</b>	Grape & Grain is retail store and comprises of an outside area with benches at the front for the consumption of drinks. Going through the main entrance the shop will divide in two main areas. First, by the main entrance, there is seating area with tables and chairs for the consumption of drinks. The rest of the floor area is dedicated to the retail of wines, beers and deli products. An access to the back of the retail area leads to the office which includes some washing up facilities. On the right hand side there are the public toilets and a little storage room. A set of stairs will lead to the cellar area and the fire exit. The main reason for the variation of the licence is to diversify the business offering on sale of wine within the premises and the outside area. That will enable us to hold in store tasting and events that will improve business.
