- <sup>4</sup> For Con29O Optional Enquiries 6, 11, 12, 13, 14 we currently hold no relevant data for these questions in Mid Sussex.
- <sup>5</sup> Con29O Optional Enquiries 4, 22 are answered by the Highways Authority, West Sussex County Council. Requested alongside a Full Con29 Search these have no additional fee. Requested as stand alone enquiries, the fee is £32.40 (inc VAT) whether one or both are required.
- <sup>6</sup> The Expedited Search Service is available for any type or combination of search request.
- <sup>7</sup> Personal Searches of the LLC Register are now only available via HM Land Registry's online service.
