#### 1. SCOPING

#### 1.1 What are the aims of the policy, service/service change or contract?

The Statement of Community Involvement describes how the Council will involve residents, businesses and other local organisations in its decision making on planning and other key matters.

The aim of the review is to produce a Statement of Community Involvement which will guide all the significant community involvement exercises undertaken by the Council, not just those by the Planning Service and be easier to read and understand.

# 1.2 Who does the service/policy/contract affect? Who are the main customers (internal or external)?

The Statement of Community Involvement has the potential to affect any one who lives, works or visits Mid Sussex.

The main customers of the Statement of Community Involvement are:

- members of the public
- Town and Parish Councillors, District Councillors
- those involved in the development industry (developers, landowners, agents)
- organisations and individuals that provide services to residents and organisations in Mid Sussex
- -organisations and individuals that represent groups of people

- internal customers include those service areas responsible for decisions that require consultation such as housing and leisure

#### Assessment of Impact and Needs - Supported with evidence from Data and Consultation

The Statement of Community Involvement (Statement of Community Involvement) describes how the Council will engage residents, businesses and other local organisations in its decision making on planning and other key matters. It was considered necessary to update the current Statement (approved in April 2006) as it is out-dated, concentrates solely on planning, is too prescriptive and suggests approaches that are resource intensive and difficult for residents to follow.

The review is being undertaken in two stages. The first stage was preliminary community involvement via a Members Working Group to produce a draft Statement of Community Involvement. The second stage is public consultation on the draft Statement of Community Involvement to help form the final version of the document for adoption by Council.

#### **Evidence**

At the Better Environment Advisory Group in March 2011, it was agreed to set up a politically balanced Member Working Group to draw up a revised Statement of Community Involvement including hearing evidence from community groups and other interested parties.

To obtain early community input, about 130 invites were sent to a variety of community groups and organisations which were considered to be a cross section of the community. The invite allowed groups to either attend a Members Working Group meeting to speak to Councillors directly or submit written representations (this Group also considered written representations submitted before this process). The overall response rate was very limited with some representation from the 'seldom heard' or protected characteristic groups. This suggests that a variety of methods should be utilised to engage with all sections of the community for the public consultation to ensure better engagement with these groups. A consultation report was published July 2011 and is available to view on the Council's website at <u>www.midsussex.gov.uk/sci</u> and will be made available at the same places as the draft Statement of Community Involvement when it is consulted on.

As a result of the information received from the community groups and organisations that engaged in the process, and a review of guidance and current best practice, a draft Statement of Community Involvement has been produced. Further consultation is planned on this draft in July and August 2011. This consultation will target all the community as best it can, proportionate to the consultation exercise. A Community Involvement Plan has been produced which details how this exercise will be done.

This Equalities Assessment assesses both the Statement of Community Involvement and the process of consultation. The draft of the Community Involvement Plan considered by the Better Environment Advisory Group will be amended to put into action the results of this Assessment.
