Outdoor Facilities Fees & Charges 2020/2021



FEES & CHARGES 2020/2021

Effective 01/06/2020 – 31/03/2021

1. The charges included in this leaflet are effective from 1st June 2020 until 31st March 2021 in relation to the Outdoor Leisure Facilities operated by Mid Sussex District Council. Summer and Winter Season Dates are specific to each site and activity. Season Dates are published at the start of each season and distributed to our Regular Hirers.
2. All hirers must complete an official MSDC Application Form and agree to adhere to the Council's published Conditions of Hire prior to the booking Period.
3. Payment for the hire of facilities must be made in advance.
4. Discounted Rates – Where a discounted rate (50% of the Full Rate) is provided, the following conditions apply:
 - Juniors – To qualify for the discounted rate facility users must be under the age of 17 at the time of hire.
 - Students – To qualify for the discounted rate facility users must be in full-time education and be able to produce a valid student card at the time of payment.
 - Unemployed - To qualify for the discounted rate facility users must be able to produce a valid JSA40 form at the time of payment.
 - Senior Citizens - To qualify for the discounted rate facility users must be aged 60 or over at the time of hire
 - Disabled Users – Discounted Rates Apply
5. VAT – Prices do not include VAT (20%) unless indicated:
 - * VAT Included
 - + VAT exempt

Block Bookings – Upon request, a 15% discount is available to regular hirers who book more than 50 sessions and whose gross expenditure on Outdoor Facility Hire exceeds £7183.22 Per annum. This does not apply to activities covered by season tickets.

Regular hirers may qualify for VAT exemption should they meet the following conditions:

- Ten or more sessions are booked in the hire Period for the same activity in the same place. Written documentation and agreement (e.g. Official Council Application Form and Conditions of Hire) must be provided to indicate this.
- The interval between bookings must be no less than one day or no more than fourteen days. The hirers use of the facility during the hire Period shall be exclusive.
- The hiring organisation must be a school, club, or association representing affiliated clubs of constituent organisations.

Funfairs and Circuses

A small funfair/circus can be described as one having 5 (or fewer) powered rides/a Big Top holding fewer than 500 people, 10 (or fewer) stalls and 10 (or fewer) temporary structures/ancillary vehicles.

A large funfair/circus can be defined as one having 6 - 10 powered rides/a Big Top holding more than 500 people and more than 10 stalls, other temporary structures and ancillary vehicles. (Please refer to the application form for specific information on designated sites).

Event Set Up & De-Rig

All days over the operating period used for set up and de-rig of the site will be charged at the 25% of the applicable published rate.

Licensed Premises

The additional charge for use of a Licensed Premises will be enforced where the benefits of the licence are utilised by the hirer to provide public entertainment in a park where such a Licence has been granted.

Tournaments

The tournament rate will only be charged where pitch marking and preparation is required by the hirer outside of (or in addition to) the regular season at a given site, and will be in addition to the relevant event charge.
