TOWN AND COUNTRY PLANNING GENERAL DEVELOPMENT
ORDER, 1950

DIRECTION UNDER ARTICLE 4 RELATING TO PARTS OR PORTIONS
OF THE BOROUGH OF REIGATE, THE URBAN DISTRICT OF DORKING
AND THE RURAL DISTRICTS OF DORKING & HORLEY AND GODSTONE.

WHEREAS the County Council of the Administrative County of Surrey (hereinafter called "the County Council") are the Local Planning Authority for the Administrative County of Surrey
AND WHEREAS the County Council are satisfied that it is expedient that development of the description set out in the Schedule hereto should not be carried out on the land comprising the parts or portions of the Borough of Reigate, the Urban District of Dorking and the Rural Districts of Dorking & Horley and Godstone shown coloured pink on Drawing No. CP.58/748 annexed hereto (hereinafter called "the said land") unless permission therefor is granted on application under the Town and Country Planning General Development Order, 1950.

NOW THEREFORE the County Council in pursuance of the powers contained in Article 4(1):(a) of the Town and Country Planning General Development Order, 1950, HEREBY DIRECT that the permission granted by Article 3 of the said Order shall not apply to the development on the said land of the description set out in the Schedule hereto (being development comprised within Class IV(2) of the First Schedule to the said Order) EXCEPT in the case of moveable structures or caravans used by travelling showmen in the course of their business.




