**Mid Sussex District Council Local Development Framework**

**Notice of public consultation on Focused Amendments to the Pre-Submission Draft Mid Sussex  
District Plan and Statement of Representations Procedure**

Mid Sussex District Council has approved a schedule of Focused Amendments to the Pre-Submission Draft Mid Sussex District Plan for public consultation. The District Plan sets the strategic framework for development in Mid Sussex up to 2031, setting out a vision and objectives with an overall strategy to implement those. The Mid Sussex District Plan is being produced for the Mid Sussex District, excluding the South Downs National Park Authority area.

The Focused Amendments have been prepared to:

- respond to the representations received on the Pre-Submission Draft District Plan in June/July 2015 in order to minimise the areas for debate at the Public Examination;
- take into account the findings of other Local Plan examinations, in particular those of neighbouring local authorities such as Horsham and Crawley; and
- have regard to the drive from Central Government to increase housing supply, including the Prime Minister's commitment to build 1m homes by 2020.

The main changes to the Pre-Submission Draft District Plan that are proposed in the Focused Amendments are:

- an increase in the housing provision figure from 650 to 800 new homes per year, which will enable the Council to make a contribution to meeting the housing needs of neighbouring authorities;
- the identification of a new strategic site for 600 homes at Pease Pottage;
- the inclusion of a housing density policy to maximise the yield from allocated sites and those in the built-up areas, thereby reducing the unnecessary loss of open countryside;
- the reversion to the previous affordable housing and developer contribution policies following the High Court's quashing of the Government's guidance on these matters; and
- updates to reflect new Government policy on self-build homes, energy efficiency, housing and accessibility standards, and Gypsies & Travellers.

**If representations were made on the Pre-Submission Draft District Plan during the public consultation in June/July 2015, there is no need for these to be resubmitted during this representation period unless there is a wish to alter or withdraw the representation in the light of the amendments made.**
