We would not have visitors to the office. We would be looking to store small amounts of bottles and cans in our store room that would be included in our gift boxes and shipped to the recipient by courier. The office is on a farm with other offices and is protected by a gate that you need to use a fob to get in and out and is only opened within office hours. There are also security cameras.

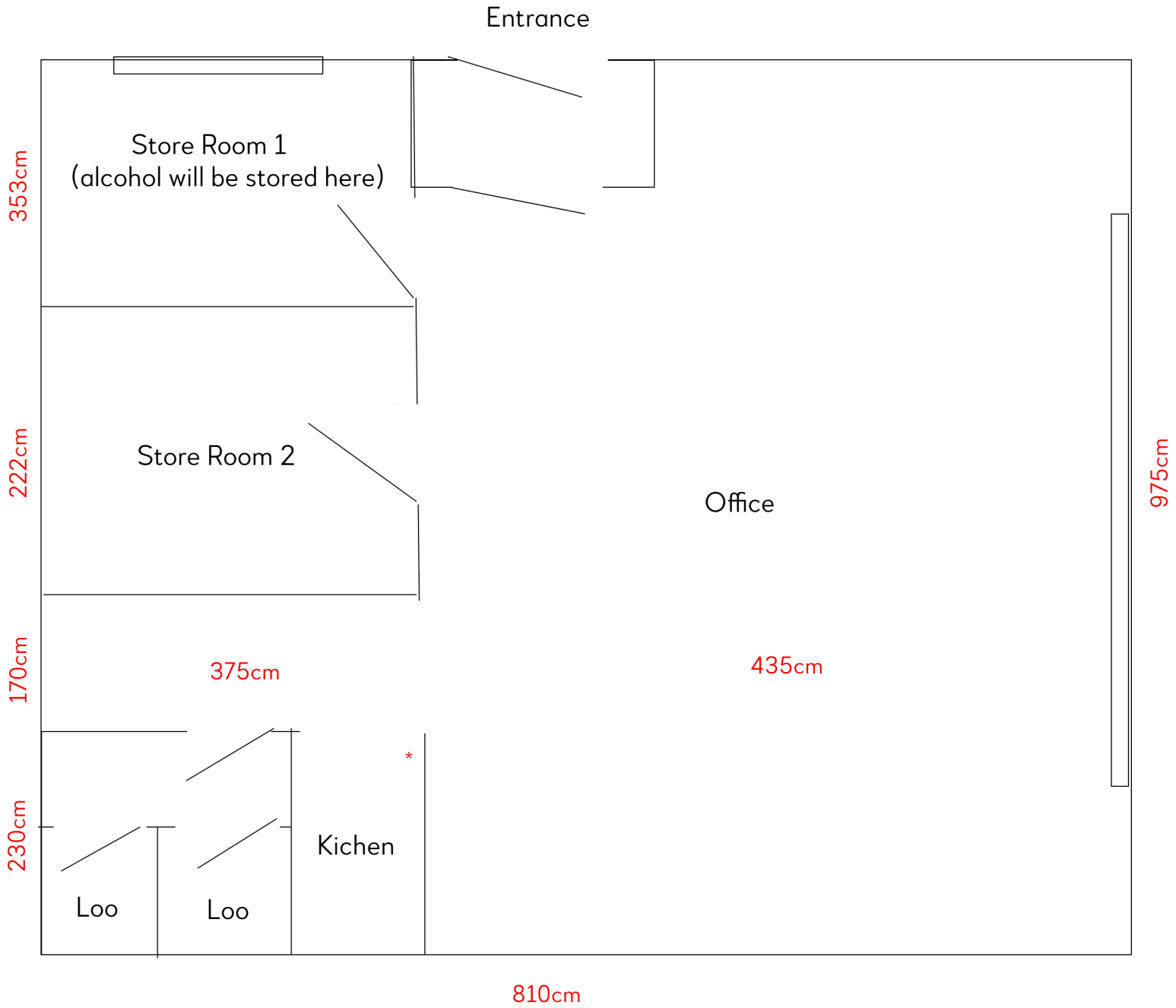


