Note that the following register parts have no entries in Mid Sussex – Part 5 - Fenland Ways Maintenance Charges, Part 7 - New Towns Charges, Part 8 - Civil Aviation Charges, Part 9 - Opencast Coal Charges, Part 12 - Land Drainage Schemes.

This table shows each part of the Local Land Charges Register (LLCR) and the types of charge that populate them. Each individual charge type is available as a layer in the MSDC Public Register Map system.

Column four of the table outlines the conditions for each charge to be in the LLCR. For example, for Planning Applications, only those which are conditional consents after 01.08.77 are in the LLCR. An older conditional consent, or an application that is refused or given unconditional consent is not in the LLCR, though you may be interested in these if you're also answering the Con29.

Many charges are only in the LLCR whilst they are active, ie their status is Active, Confirmed, Served etc, as detailed in the table above. Again, charges that are no longer active are not part of the LLCR. For example, only WSCC Highways Agreements that are Served are in the LLCR, not those that have now been Adopted or Superseded.

Column five, "Further Info" indicates where further information is available about this charge type.

How to search the LLCR

1. In the Public Register Map, begin by clicking "MSDC – Local Land Charges" and click on the layers you require for the part of the LLCR you are searching. Or select all the layers if you wish to search every part of the LLCR at once.

2. Enter the address of your search property in the "Address search" box. Type the street name first, and the available addresses will pop down to select from. Click on the required address. Use the + and – buttons (or roll the mouse wheel) to zoom in and out of the map. It is recommended you zoom in closer so the search site fills the screen, to avoid gathering records from adjacent properties.

3. Click anywhere on the map to reveal the layers at that point. They appear as "Layers" in the left column. Click on any of these charge types to see specific records, they will be listed as "Objects", if there are more than one. Click on any of these to see the full details ("Attributes") and note any that are in the LLCR, using the aforementioned "conditions" column four above. Click on the back arrow next to "Attributes" to return to the list of objects. Click the back arrow next to "Objects" to return to the list of Layers on the point you have selected on the map. Continue until you have all the information you require, ie all of the layers that cover or partly cover your search site.
