1. SCOPING

1.1 What are the aims of the policy, service/service change or contract?

Mid Sussex District Council has prepared a Haywards Heath Town Centre Masterplan Supplementary Planning Document (SPD) to supplement a specific policy in the Mid Sussex development plan (District Plan policy DP2: Town Centre Development). The Masterplan SPD provides a framework and guiding principles for planning decisions within the defined Town Centre boundary.

The SPD provides guidance on policies which have already been adopted in the Mid Sussex District Plan 2014-2031. It does not provide new policies but rather provides guidance that sets out in more detail how the policies in the District Plan should be implemented. The District Plan was accompanied by an EqIA.

The aim of the SPD is to provide a framework for economic vitality, recovery and growth. An adopted Masterplan demonstrates the intentions for regeneration and renewal which in turn provides more clarity for the community, those looking to invest (including supporting future investment priorities and decisions) and those planning development and infrastructure.

The SPD will be subject to public consultation, which will involve all members of the community.

The results of this Equality Impact Assessment will be used to inform the Community Involvement Plan that will detail the consultation arrangements with stakeholders and the community.

1.2 Who does the service/policy/contract affect? Who are the main customers (internal or external)?

The SPD is based upon the policies contained within the District Plan, which have the potential to affect anyone who lives, works or visits Mid Sussex – particularly Haywards Heath which is the focus of this SPD.

The main users of the SPDs are likely to be:

- Members of the public:
- Those involved in the development industry such as developers, architects, landowners, agents;

- Those looking to invest in the SPD area;
- Development Management Officers;
- District, Town and Parish Councillors;
- Organisations and individuals that represent groups of people;
- Internal customers such as Economic Development, Parking, Estates and Leisure

1.3 What equality information is available, including any evidence from engagement and analysis of use of services?

The SPD is based on the policies contained within the District Plan, which has been subject to its own Equalities Impact Assessment. The SPD will be the subject of full public consultation. A Community Involvement Plan, informed by the results of this Assessment, will detail how the consultation will be undertaken.

There has been early engagement with others during the production of this SPD, providing a range of expertise and advice.

These include:

- Specialist Urban Design and Transport consultants;
- A Member Workshop comprising Councillors;
- West Sussex County Council officers giving advice on transport issues, which have implications re: accessibility.

As well as internal Council officers, including:

- Economic Development
- Estates
- Parking
- Leisure

1.4 What does this information tell us about the equality issues associated with the service and implications for the protected groups?

Engagement with these groups has ensured a board range of opinions have input into the production of the SPD at an early stage.

The upcoming public consultation will also improve the Council's ability to receive input from an even more diverse range of voices, ensuring the final document is responsive to the needs of all groups of society.

The document will be available to view digitally, on the Mid Sussex District Council website, and hard copies will be available to view at key locations provided it is safe to do so given the Covid-19 pandemic. The Council will also be directly reaching out for responses to the consultation by utilising the Planning Policy Updates database which includes over 500 subscribers, who will receive notification and further information about the consultation.

Mid Sussex District Council has identified a number of hard to reach groups, and these groups are included in this database.
