There will be no 3rd party delivery partners so the business will have all control of where the products go. The premises is a detached garage with extra reinforcements for security. Sales and distribution will all be off site so no customers will be at the property at all times. All the alcohol will be delivered without interference from Booze Spot.

Booze spot is a web based alcohol delivery company. All orders will be processed online only. The orders will be fulfilled when the customers enter a residential or business address only. The alcohol will be consumed off premises. The business will deliver all the orders ourselves without the involvement of any 3rd parties. Booze spot operates a strict challenge 25 policy that will be advertised on the website when visiting the site and at the checkout stage too.

The prevention of crime and disorder:

All purchases will have to be done online only and alcohol delivered to a residential or business address only. Customers not allowed on premises at all times.
Advertising will detail as a delivery service and state challenge 25 is in place with recommended forms of ID to be accepted.
The alcohol will be stored in a garage with new locks on the garage door and boarded up windows to heighten safety.
CCTV installed further down the line for further security will be compliant with GDPR regulations and rules. The data will be stored and available to relevant authorities that require it.
Having a refusal register.
We will keep records of all orders made for 21 days in case the information is needed further down the line.
In the event that the person ordering and paying for the alcohol nominates another person as the recipient as a gift, the customer will have to provide the information prior and the recipient will need to provide ID before the order is released.

Public safety:

Training staff to be aware of different situations that may be a danger to them or customers.
Staff will be instructed to contact police where peaceful diffusion of the situation isn't possible.

The prevention of public nuisance:

The business will not have any customers in the premises.
All alcohol will be consumed off the premises.
The business will operate remotely as much as possible by stacking as many orders as possible to reduce any noise complaints.

The protection of children from harm:

Booze spot will work to utilise challenge 25 at all times.
The website will require the person purchasing the alcohol to be the one to collect it with proof of age being requested if need be.
The business will only accept photographic government ID and communicate that with the customers.
Training staff on the right ID and what to look for in verifying ID.
The site will have age verification as a requirement before a sale is finalised. This will be used to verify the customers age before releasing the order.

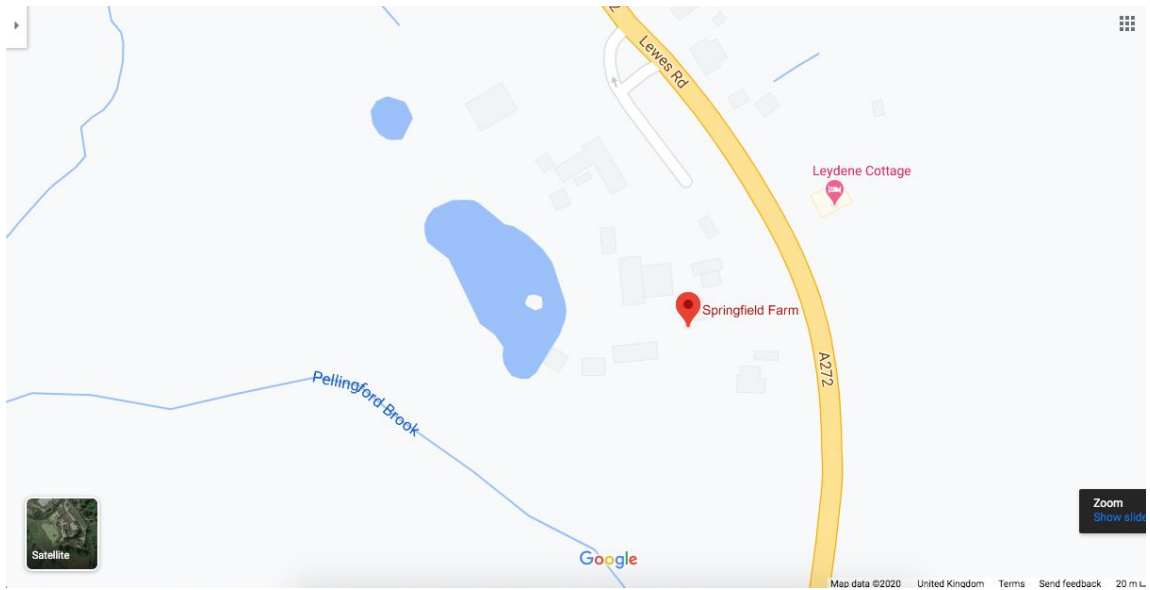

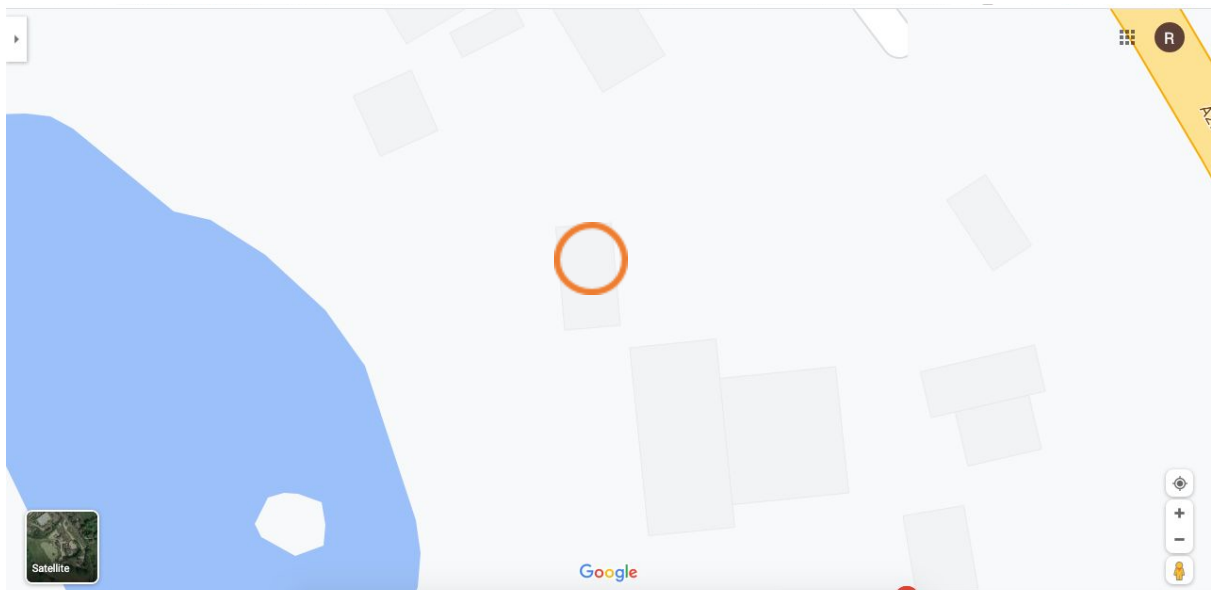

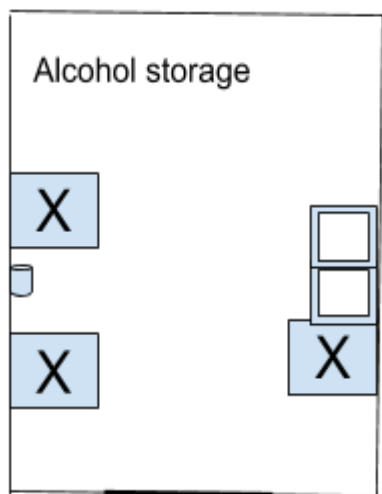
