Dear Andy

Thank you so much for your suggested meeting dates and times and draft agenda.

I believe in order to keep the progress with the application it would be best to 'meet' on 9th October, so I look forward to receiving a link invitation.

In terms of attendance if you can give me some more information I can then advise who will attend along with me.

1. I note that Virginia Pullan is not on the list of your attendees. Is this because you anticipate a written response to our letters to Virginia? I had hoped that our respective landscape architects could agree at the meeting where they have common ground, and what is necessary to overcome the objection. However, if we have a revised written response that may not be necessary. Perhaps if she can't attend and will not be revising her written response she could speak directly to our landscape architect and me in advance? Please can you confirm?
2. With regard to your agenda item on the need methodology can you give me some more information on what your specific queries are so that I can judge whether our need expert will attend. Again I note that you do not have a Crematorium need expert identified in the attendees for the meeting, have you commissioned a report or obtained advice as you suggested in the pre-application response, if so that would be helpful to have in advance of the meeting.
3. I note that there is no response to the application on ecology/ biodiversity yet. Do you anticipate this being available before the 9th of October? Again if this raises queries of a specialist nature it may be appropriate for our ecologist to attend. Perhaps you could confirm?

In order to aid minute taking can you please confirm that we can record the meeting?

In addition to the agenda items you have raised I had also wanted to confirm the determination deadline given the variance between the validation letter and the Council's website. It would also be useful to discuss draft planning conditions and in particular any pre-commencement conditions.
