Dear Andy,

I have this afternoon copied you in to a letter to Edward Anderson regarding the minerals resource assessment that he requested as part of the assessment of the above application. I believe this satisfies the minerals planning authority and should lead to a response of no objection to the proposal.

I note that the detailed comments in relation to the landscape architects' consultation response are now available on the Council's website. I have left a voice message for Virginia Pullan on her direct line asking to arrange for a meeting next week to discuss her objection so we can look to overcome any outstanding matters. I understand your Council operate using Microsoft teams so I would be grateful if you could help facilitate a video meeting on Microsoft teams with Virginia that both the landscape architect and I can attend.
