Further to our meeting and my email of Friday 10th October I now attach three additional items as promised.

1. Note setting out the minor discrepancies between the 'as built' access with the proposal. You will note from the detailed plans highlighted in the note that the proposal does not require the removal of any hedgerow.
2. Photos from Hamdown Natural Burial ground in Dorset. These show the woodland character of the mature parts of the burial site.
3. Letter from Mark Gibbins (Landscape Architect) setting out what we believe to be points of common ground on landscape and visual impact.

In addition, in order to assist the interpretation of the relative impacts of the fallback and the proposal, I attach two additional cross-sections in drawing 917-MP-06A that compares the impact from viewpoint 12 of the LVIA. This additional drawing showing sections B-B and C-C compares the impact of the consented chapel building and that of the proposed crematorium building from the same view point position from within the AONB. Please can this drawing be added to package of application drawings.
