Further to previous correspondence, I received updated comments from Virginia Pullan yesterday, which were uploaded to the website then. There are a couple of points I wish to clarify and hence I will be discussing them with her on Monday.

Unfortunately due to the weather this week, I have not visited the site to verify my own views, but I am hopeful I can do so next week. I will then update you more fully.

In the meantime, Virginia has identified that there is one point of correction/clarification regarding point 1. 4 in the letter from Mark Gibbins dated 12 October. The Mid Sussex LCA 6 is in fact the High Weald and not High Weald Forest Ridge.

Furthermore, with regards to setting of the AONB, there is a reference in the LVIA at paragraph 3.2.10 to the NPPG advice with regard to setting of protected landscapes – but the NPPF only specifies development within these areas at para 172.
