The premises will operate as an Italian Restaurant. There has been a similar restaurant operation in place at this site during the last 15 years. The current owners are very experienced in the licensed restaurant trade having run restaurants during the past 20 years in London. CCTV will be installed, Staff will be trained, a refusals register will be maintained and Challenge 25 Age Verification Policy implemented. The nature of the business and the experience of the owners will not compromise the licensing objectives.

The prevention of crime and disorder:

CCTV will be installed, Staff will be trained, a refusals register will be maintained and Challenge 25 Age Verification Policy implemented. The nature of the premises and the licensable activities planned will not compromise this licensable activity . Suggested conditions
1.Digital CCTV and appropriate recording equipment to be installed ,operated and maintained in the premises to cover the counter and the entrance to the premises. The system shall be on and recording at all times the premises licence is in operation. a. The CCTV cameras and recording equipment must be of sufficient quality to work in all lighting levels inside the premises at all times. b. CCTV footage will be stored for a minimum of 28 days c. The CCTV images will record and display dates and times, and these times will be checked regularly to ensure their accuracy. d. The management will give full cooperation and technical assistance to the Police in the event that CCTV footage is required for the prevention and detection of suspected or alleged crime. e. Subject to Data Protection guidance and legislation, the management of the premises will ensure that key staff are fully trained in the operation of the CCTV, and will be able to download selected footage onto a disk for the police without difficulty or delay and without charge to Sussex Police. f. Any breakdown or system failure will be notified to the police via 'phone (currently 101) or email immediately and remedied within a time scale to be agreed with Sussex Police. 2. All staff members engaged, or to be engaged, in selling alcohol on the premises shall receive full training pertinent to the Licensing Act, specifically in regard age-restricted sales, and the refusal of sales to persons believed to be under the influence of alcohol or drugs. Induction training must be completed prior to engaging in any sale of alcohol. Refresher training shall be conducted thereafter at intervals of no more than six months. All restricted sales training undertaken by staff members shall be fully documented and signed by the employee and the DPS. All training records shall be made

immediately available upon request to officers of a Responsible Authority. 3. A refusals record must be kept at the premises which details all refusals to sell alcohol. This record must include the date and time of the incident, a description of the customer, the name of the staff member who refused the sale and the reason the sale was refused. All entries must be made within 24 hours of the refusal. The DPS must review and sign the record at intervals of no more than eight weeks. The record must be made immediately available upon request to officers of a Responsible Authority.

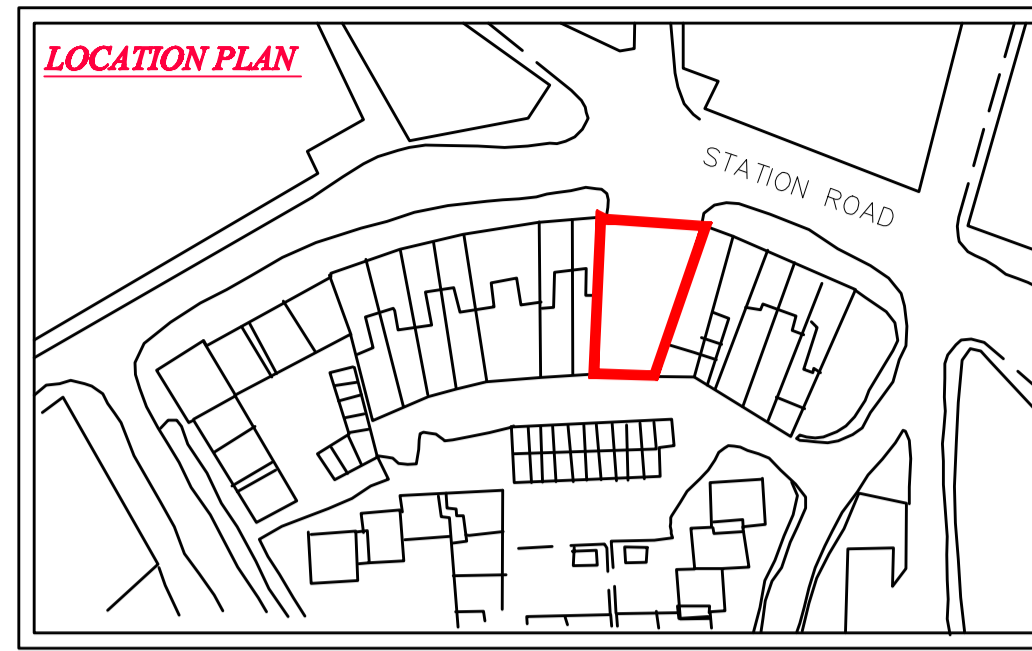

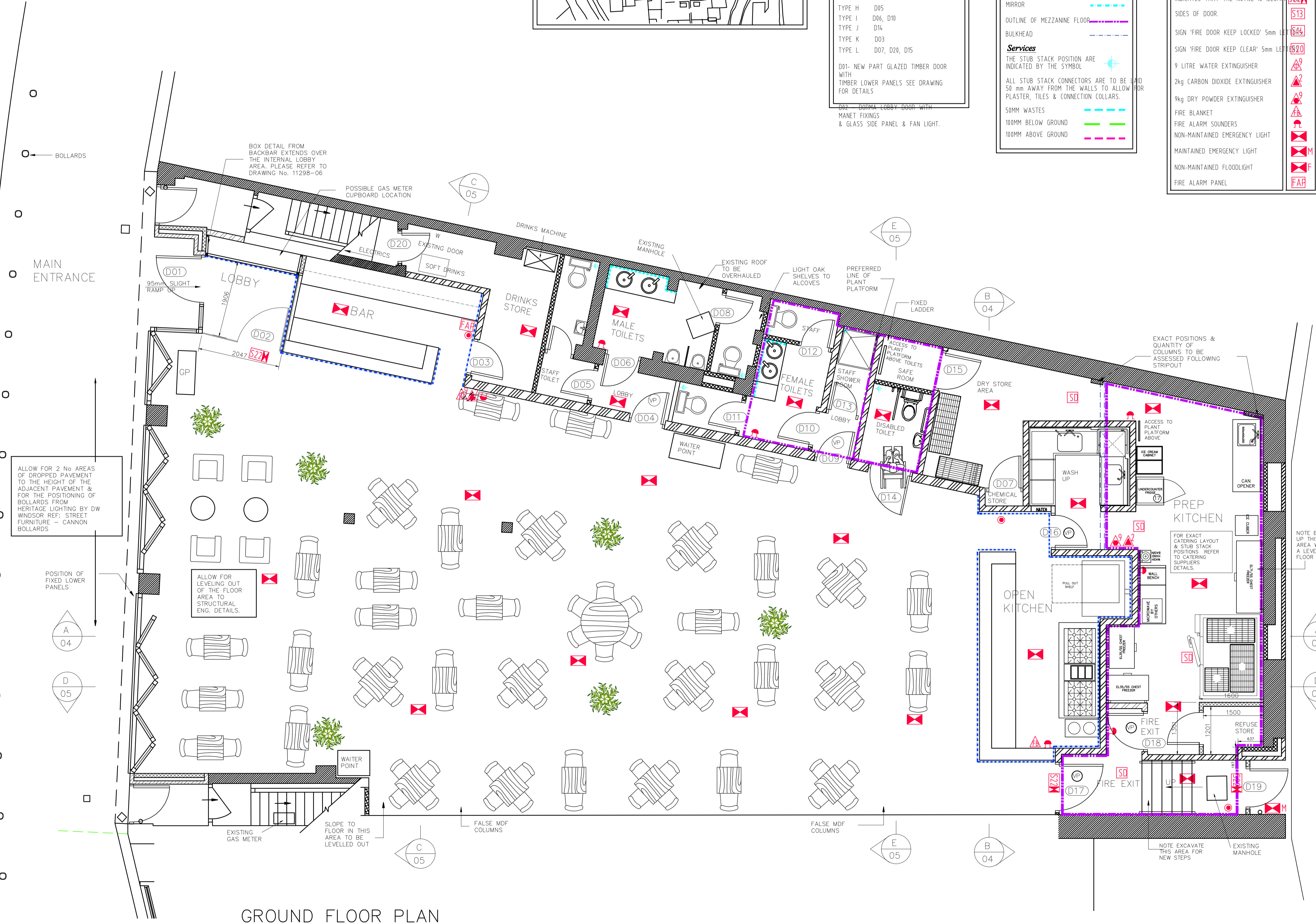
