Dear All,

I hope everyone has been keeping safe and well over the summer period.

I thought I would write to give everyone an update as to where we are with the Site Allocations DPD Examination in Public.

As many of you will most likely be aware, there were a number of <u>action</u> <u>points</u> set throughout the hearings that the Council have been progressing

with over the summer period. There are still a few outstanding Action Points (AP16, AP18 & AP21). The list of Action Points have been published in a list as <u>ID-05</u>. This list and all responses received to date are placed under the heading 'Post Hearing Actions' on the <u>examination</u> webpage.

The Inspector is allowing responses from duly made (yourselves), interested parties to the remaining action points listed below;

### AP2- Matter 1.2

(i), <u>AP5</u>, <u>AP7</u>, <u>AP10</u>, <u>AP11a</u>, <u>AP11b</u>, <u>AP11c</u>, <u>AP11d</u>, <u>AP11e</u>, <u>AP11f</u>, <u>AP12</u>, <u>AP13</u>, <u>AP14</u>, <u>AP15</u>, <u>AP17a</u>, <u>AP17b</u>, and <u>AP19</u>.

The Inspector has also published <u>ID-08</u>. This is a question to the Council and interested parties regarding the revised NPPF.

All responses to the action points listed above and the Inspectors note (ID-08) on the revised NPPF must be e-mailed to me by the end of Thursday 9th September 2021. Once the remaining action points are completed and published I will send another communication to advise of a deadline to respond to them.

Once the Inspector has received the remaining responses to action points, he will be able to consider all the additional material. He will then need to decide if an additional hearing is necessary in relation to sites SA12 and SA13 (South of Folders Lane sites). Once the Inspector has made all these considerations he intends to submit some form of Interim Findings.
