Examination News Updates

15th April 2026

At the hearings, the Council agreed to produce a 'long list' of additional sites that would be required to meet the Inspector's 1,200-1,300dpa target housing requirement range. Sites on the long list will be subject to in-combination testing (such as transport modelling and Sustainability Appraisal) before the Council finalises any additional proposed allocations and consults on them.

The Council published a methodology for selecting the sites for the long list (MS-14) which the Inspector has agreed (IDJB-12).

The Council can confirm that it proposes to publish the long-list of sites on Friday 15th May. In-combination testing will commence thereafter.

8 April 2026

Some representors have asked whether they can participate in the discussion on Matter 6, scheduled for 8 March, to make comments about sites that have not been included in the plan. It is important to recognise that the Inspector is examining the soundness of the plan itself and its site allocations, not housing sites that have been omitted from it. The Matter 6 session is necessary to understand and assess the soundness of the Council's site selection process, but this will be at a high level. There are several omission sites and it would be an inefficient use of examination time to hear detailed representations about their merits and demerits either from objectors or from site promoters. The Inspector will therefore not accept or consider such representations.
