Describe the premises	<p>The type of premises is a camping and caravan park. Situated at the junction of Lodge Lane and New Lane. A Secluded location, with no properties directly adjacent.</p> <p>The Layout, where the alcohol will be sold is near the entrance of the park in the main shop and the coffee shop situated opposite the main reception/shop. There is the shower blocks, car park and recycling, is in the same area. The camping fields are situated behind hedges away from the reception and coffee shop. There is only 1 entrance and exit, which is locked at 11pm at night and is covered by 24hour CCTV. which also covers all areas that alcohol sales will take place. The rest of the site is secure, with no footpaths or entry around the rest of the site. We also have 24 hour staff cover onsite.</p> <p>The recycling is also situated in the main reception area so any waste is disposed of appropriately, Toilets are available for use of staff and guests. Fire procedure's are in place and the meeting point is situated in the car park and all signage is in place and adheres to current legislation. The sale of alcohol is purely for guests staying on site.</p>

Please list here steps you will take to promote all four licensing objectives together.	We are a charity, campsite, who have been in Hassocks for almost 20 years. We have never had any public disturbances or problems from our guests. We would like to enhance our campers experience and add to their stay. We have recently welcomed a mobile coffee truck to the site, which has been very successful and the guests love it. Lisa the owner of the coffee truck, organized a cocktail evening on the August bank Holiday 2025 with a TENS license, which proved to be a great success, with no issues arising hence we would like to build on this. Lisa has been a licensee since 2017 and has run numerous mobile bar events for weddings etc. She is our proposed DPS for the site and will operate a strict challenge 25 policy. Lisa also holds her own public liability insurance for the provision of mobile bars. The coffee truck Lisa currently operates on site has a food hygiene rating of level 5 with the local Authority and this where bar sales will take place from. We have disabled guest visiting us, who are not always able to get out to socialize, this provision will provide a great opportunity for them to socialize with other guests within a safe and secure environment, as it promotes a general meeting place within the site. We have all our health and safety policies in place, including fire regulations, safeguarding and public liability insurance. We have all facilities in place such as recycling receptacles, toilets, 24 hour CCTV and 24 hour Staff presence. We also have a first aider, defibrillator, accident book, all staff are trained in the use of these. We are not applying for any music or event licenses which could disturb residence in the local vicinity and only intend the sale of alcohol to be for the guests staying on the campsite.


