Describe the premises	<p>Pink Flamingo is a ground-floor commercial premises located on The Broadway, Haywards Heath, within a mixed-use high street area comprising retail, hospitality, and residential properties. The premises operates as a bar, restaurant, and late-night social venue. It comprises a main internal trading area with a fixed bar server, customer seating and standing areas, and associated customer facilities. A fully equipped commercial kitchen is located to the rear of the premises. There is a small external front terrace area immediately outside the premises frontage, used during permitted hours, and a rear external area which is not used after 23:30 to minimise noise disturbance. The premises has defined access and egress points, appropriate fire exits, and is operated in accordance with all relevant health, safety, and licensing requirements.</p>

Please describe briefly, the nature of the proposed variation	<p>The application seeks to vary the premises licence to extend the permitted hours for the sale of alcohol and the provision of regulated entertainment, including recorded music and live DJ-led events, on specified days. Objectives

Licensing Objectives	
Please list here steps you will take to promote all four licensing objectives together.	The premises will operate with a strong focus on promoting all four licensing objectives. Staff will be trained in responsible alcohol service, Challenge 25, and customer care. CCTV will be installed and maintained, with footage available to authorities on request. Capacity limits will be monitored, sound levels controlled, and dispersal managed to minimise nuisance. Clear policies will be in place to prevent crime, protect public safety, prevent public nuisance, and safeguard children from harm. SIA door supervision from 21:00 hours is only required when a late opening beyond 23:59 is planned. Where no regulated music takes place beyond 23:59, the sale of alcohol ends at 23:40, and the premises closes by 00:15, SIA door supervision is not required.
The prevention of crime and disorder	The premises operates a zero-tolerance approach to crime and disorder. CCTV is installed and maintained throughout the premises, with recordings made available to responsible authorities upon request. Staff are trained in conflict management, responsible alcohol service, and the refusal of service where appropriate. All incidents are recorded and managed promptly, and the premises will cooperate fully with local police and licensing authorities at all times.
Public safety	The premises is maintained to a high standard of safety and compliance. All fire safety equipment, emergency lighting, and escape routes are regularly inspected and kept clear at all times. Staff are trained in emergency procedures, first aid awareness, and crowd management. Capacity limits will be monitored and adhered to, and risk assessments will be carried out for events where appropriate.
The prevention of public nuisance	The premises will operate with consideration for nearby residents. Sound levels will be actively monitored and controlled, with doors and windows kept closed during regulated entertainment except for access and egress. Outdoor areas will be managed to minimise noise, with signage requesting customers leave quietly. Staff will supervise dispersal at closing time, and any complaints will be addressed promptly.
The protection of children from harm	The premises will operate a strict age-verification policy, including Challenge 25, for the sale of alcohol. Children will only be permitted on the premises when accompanied by a responsible adult and at appropriate times. Clear signage will be displayed. Staff will be trained to prevent underage sales and to identify and respond to safeguarding concerns. No adult entertainment or inappropriate material will be provided.
