Please list here steps you will take to promote all four licensing objectives together.	<p>New members may make use of the cricket facilities for sporting activity but may not make use of the licenced premises until a period of forty-eight (48) hours has elapsed since the date of the application to join the club.</p> <p>Club members may sign in a maximum of two (2) guests at any one time (this does not affect visiting teams, scorers, umpires, etc.)</p>
The prevention of crime and disorder	<p>The Club shall at all times maintain and operate a sales refusal log and an incident log to record all refusals and incidents of crime and disorder. These shall be reviewed and signed by a club committee member at intervals of no more than four (4) weeks. All members engaged in selling alcohol on the premises will ensure these logs are used on each occasion that a refusal or incident occurs at the premises. These records shall be kept at the club for a minimum of twenty four (24) months and made available upon request to the Local Authority Licencing Officers and Sussex Police Officers.</p>
Public safety	<p>After 21:00 hours all children under eighteen (18) years of age must be accompanied by a responsible adult. Children under the age of sixteen (16) years of age must be accompanied by their parent, guardian, or another appointed adult at all times when in or around the clubhouse. When the club is not open, all alcohol stock will be secured in the locked drinks fridge in the clubhouse. Any additional stock will be secured in the storage container adjacent to the premises, which is used to house the club ground machinery.</p>
The prevention of public nuisance	<p>All Club members engaged, or to be engaged, in selling alcohol on the premises shall receive full training pertinent to the Licencing Act 2003, specifically regarding age-restricted sales, and the refusal of sales to persons believed to be under the influence of alcohol or drugs. Induction training must be completed prior to engaging in any sale of alcohol. Refresher training (which may be verbal enforcement) shall be conducted thereafter at intervals of no more than sixteen</p>
The	<p>(16) weeks. All restricted sales training undertaken by members shall be fully documented and signed by the member so trained and by a member of the club committee. All training records shall be retained at the Club and made available upon request to the Local Authority Licencing Officers and Sussex Police Officers</p>

The Club will operate an age verification policy set at a minimum 25 years, whereby any person attempting to buy alcohol who appears to be under this specified age will be asked for photographic ID to prove their age.  
Signage advertising the "challenge" policy will be displayed in prominent locations within the premises and shall include the point of sale and the area where the alcohol is displayed, as a minimum.
