The site is a small Café/Restaurant of 20 covers selling a combination of English and Turkish cuisine
 The owners wish to offer their customers the opportunity to purchase alcohol.
 They also run a food delivery service and wish to offer the facility to provide alcohol with such deliveries via internet sales.
 Their web site takes account of age verification and we have suggested conditions for delivery.

The suggested conditions take account of the nature of the site and the clientele it intends to cater for.

1. CCTV

a. Digital CCTV and appropriate recording equipment to be installed in accordance with Home Office Guidelines relating to UK Police Requirements for Digital CCTV System (PSDB Publication Number 09/05), operated and maintained throughout the premises internally and externally to cover all public areas, including the entrance to the premises. The system shall be on and recording at all times the premises licence is in operation.

b. The CCTV cameras and recording equipment must be of sufficient quality to work in all lighting levels inside the premises at all times.

c. CCTV footage will be stored for a minimum of 31 days.

d. The management will give full and immediate cooperation and technical assistance to the Police in the event that CCTV footage is required for the prevention and detection of suspected or alleged crime.

- e. The CCTV images will record and display dates and times, and these times will be checked regularly to ensure their accuracy.
- f. Subject to GDPR guidance and legislation, the management of the premises will ensure that key staff are fully trained in the operation of the CCTV, and will be able to download selected footage onto a disk (or other electronic portable device acceptable to Sussex Police) for the police without difficulty or delay and without charge to Sussex Police.
- g. Any breakdown or system failure will be notified to the police immediately & remedied as soon as is practicable.
- h. In the event of the CCTV system hard drive being seized as evidence as part of a criminal investigation by Sussex Police or for any other reason, the premises will be expected to install a replacement hard drive or a temporary replacement drive as soon as practicable.

2. Training/Authorisation:

- a. The Premises Licence Holder shall ensure that all staff members engaged, or to be engaged, in selling alcohol at the premises shall receive the following induction training. This training will take place prior to the selling of such products:
 - *The lawful selling of age restricted products
 - *Refusing the sale of alcohol to a person who is drunk
 - *Recognising and dealing with proxy sales
- b. Further verbal reinforcement/refresher training covering the above will be carried out thereafter at intervals not to exceed 6 months, with the date and time of the verbal reinforcement/refresher training documented.
- c. All such training undertaken by staff members shall be fully documented and recorded and signed by both the employee and the DPS. All training records shall be kept on the premises and made available to Sussex Police, officers of the local authority and officers from the Trading Standards team upon request.
- d. A list of staff members who are authorised to sell alcohol on the premises shall be kept. This shall be endorsed by the DPS with the date such authorisation commences.

3. Incident/Refusal Log:

- a. An incident/refusal log will be maintained by the premises showing a detailed note of incidents that occur in the premises. The log will be inspected and signed off by the DPS (or a person with delegated authority) at least intervals of no more than four (4) weeks.
- b. The log book should be kept on the premises and be available for inspection at all times the premises are open by authorised officers of the Licensing Authority or the Police.

4. Alcohol will only be served to customers who partake of a sit down meal.

5. The ordering and service of alcohol to customers in the premises will be made via serving staff only.

Conditions for delivery of alcohol

5. Alcohol sold via internet or other electronic communication for delivery may only be delivered to a residential or business address as an accompaniment to food ordered from the premises.

6. The premises will operate an age verification policy set at a minimum of 25 years

7. Signage advertising the “Challenge” policy will be displayed on the premises website/advertising.

8. The date of birth of a customer ordering alcohol will be recorded at the time of the order.

9. Records of alcohol deliveries will be retained for 12 months and will be available for inspection at the premises to any officer of a Responsible Authority.

10. A refusal log must be maintained where a delivery cannot be made due to age the restriction or the intoxication level of the recipient.

11. All staff members engaged, or to be engaged, in selling alcohol on the premises shall receive full training pertinent to the Licensing Act, specifically in regard age-restricted sales. Induction training must be completed prior to engaging in any sale of alcohol. Refresher training shall be conducted thereafter at intervals of no more than six months. All restricted sales training undertaken by staff members shall be fully documented and signed by the employee and the DPS. All training records shall be made immediately available upon request to officers of a Responsible Authority

c) Public safety

All electrical certificates, fire safety and health and safety policies are up to date . .

d) The prevention of public nuisance

We do not intend to have entertainment on a regular basis and do not anticipate the day to day activities at the site to compromise this Licensing Objective.

e) The protection of children from harm

A Challenge 25 Age Verification Scheme will apply, all Staff will be appropriately trained regarding the supply of alcohol direct to and via proxy sales to those who are under 18. A refusals and incident register will be maintained.

13. Challenge 25:

- a. The premises will operate an **age verification** policy set at a minimum of 25 years (e.g. "Challenge 25") whereby any person attempting to buy alcohol who appears to be under the specified age e.g. 25 will be asked for photographic ID to prove their age. The recommended forms of ID that will be accepted are passports, official Photographic Identity Cards issued by EU states bearing a hologram or ultraviolet feature, driving licences with a photograph, photographic military ID or proof of age cards bearing the 'PASS' mark hologram.
- b. Signage advertising the age verification or 'Challenge 25' policy will be displayed in prominent locations in the premises.


