Information recently received regarding the above address indicates that a member of your household is in a full-time course of education and studying within the European Union.

A full-time course of education is defined as one which continues for at least one academic or calendar year, where the person undertaking it is normally required to undertake on average, 21 hours of study, tuition or work experience, for at least 24 weeks in that year. Please note that with the exception of the initial training of teachers in schools, periods of work experience should not exceed periods of study/tuition for the course as a whole.

**Please complete and return the enclosed application form together with the following information: -**

- A copy of the letter confirming acceptance on the course
- Proof of enrolment details
- Key details of the course (duration, hours, syllabus etc)
- Confirmation of payment for the course (this may be an invoice)
- Contact name & address of the institute course administrator to whom the local authority can seek further information.

In addition to the discount, the property could be fully exempt from Council Tax if all the occupiers are students (full time students, or further education students aged 18 or 19), or the only other occupiers are the non-British spouse or non-British dependant of one of the students (whose entry into this country prevents them from taking paid employment or claiming benefits).

If you think this exemption might apply, please contact the Council Tax office with details.

Should the circumstances of the person studying or the number of adult persons in the household change after you have completed the form, you must notify the Council Tax office within 21 days of the change. In the meantime, if you have any queries, please contact the revenues department.
