We plan to run a weekly darts academy for ages between 8-17 - in groups depending on popularity and different age groups. During these sessions the bar area will be closed off and only soft drinks and snacks will be sold. These groups will be ran by multiple members of staff.

ID checks and refusal document which will be reviewed regularly. CCTV throughout the premises. Have clear rules and policies in place to deter any anti social behaviour.
The prevention of crime and disorder	We will always have 2 or more members of staff on site when the sale of alcohol is permitted. We will ensure all staff are trained in recognising signs of intoxication, handling difficult or aggressive customers and underage drinking. We will implement the challenge 25 policy when serving alcohol and challenge anyone who looks to be 25 or below for ID and keep a record of refusals behind the bar area. We also have CCTV throughout the premises, to deter anti social behaviour or criminal activity.
Public safety	We will comply with fire regulations (extinguishers, exit points and alarms), always have at least one first aid trained member of staff on site, we will also have contact information for local taxi companies/public transport options, will always have the shop well lit and CCTV monitoring. We will always challenge 25 and refuse if failure to comply, we will also refuse service to intoxicated individuals. Any incidents that occur will be noted/reported and be reviewed regularly.
The prevention of public nuisance	Noise - we will control music volume and have acoustic boards in shop to dampen sound. Train staff to deal with intoxicated or disruptive customers. We will have bin/recycling points throughout the upstairs and outside to avoid littering. These will be monitored regularly. No drinking promotions. We will also display signs on the route to exit to remind customers to respect neighbours and have transport options available.
The protection of children from harm	Challenge 25 Policy will be implemented. Train staff to recognise and refuse underage customers. Ensure children have a responsible adult accompanying them when using our board rental. During academy sessions we will close the bar area and only serve soft drinks. Have a secure bar area that can be closed/locked ensuring no children can access alcohol. Have children only sessions available weekly. Also having CCTV monitoring our premises.
